



REGULATIONS FOR PARTICIPATION IN THE CALL FOR ARTISTS – ROMA BUSKERS FESTIVAL 2026

3–5 July 2026 | Rome Tourist Port

The Roma Buskers Festival is an event dedicated to **street artists**, which has been promoting the culture, music, and vibrant soul of Rome’s Municipio X for years, offering the public a unique entertainment experience driven by creativity. With this Call for Artists, we invite all artists to apply to take part in the 2026 edition of the Festival.

The Organization also reserves the right to invite certain artists to participate on an exclusive basis, in addition to those selected through the Call.

ARTIST SELECTION

To participate in the selection process, applicants must send the required material, consisting of at least one video and/or audio file representative of the artist’s performance.

Incomplete applications or applications without audio/video material will not be considered.

APPLICATION TERMS & CONDITIONS

PARTICIPATION & SCHEDULE

By submitting their application, selected artists confirm their availability to participate in the event and commit to respecting the schedule and locations assigned by the Organization.

- Performances: Artists will perform every evening from 19:00 to 24:00, following a rotation among the assigned spots. The Organization reserves the right to determine the dates, times, and locations of performances, both for street positions and for the main stage.

ADDITIONAL TERMS & CONDITIONS

- The Organization may invite artists to take part even after the Call deadline, based on particular artistic merit.



- The names and information of selected artists will be published on the official Festival website and social media channels.

EXPENSE REIMBURSEMENT & ACCOMMODATION

The Organization reserves the right to decide, at its own discretion, whether to provide the following benefits and to what extent they may be granted to participants:

- **Expense reimbursement:** Selected artists may receive reimbursement for travel expenses, according to the methods established by the Organization.
- **Accommodation:** The Organization may cover accommodation costs for artists during the Festival days.
- **Meals:** Meals will be provided by the Organization during the Festival evenings.

MEDIA & IMAGE RIGHTS

During the Festival, photographic and video recordings will be made and may be freely used on the event's official social and media channels, as well as on those of the event partners and by Gruppo Matches SRL, the Agency holding exclusive rights over the event.

By agreeing to take part in the Festival, participating artists waive any request for compensation or rights regarding the images, videos, and recordings taken during the event, both now and in the future. Such materials may be used without time or geographical limitations for event promotion and communication.

SPECIAL REQUIREMENTS

Any special needs of the artists will be evaluated on a case-by-case basis and, if necessary, the Organization will provide specific support.

PERFORMANCE OPPORTUNITY

All selected artists will be able to perform within the Festival and will be allowed to busk for tips, in keeping with the street art tradition.

By participating in the Call for Artists, applicants accept all the conditions outlined in these regulations.
